What is a cookie?

"Cookies" are small files that we place on your computer or smartphone when you visit our MYPETSTORIES platform. Their purpose is to make the application and our website work and to provide us with information about your navigation on the Platform.

Cookies allow our MYPETSTORIES platform to remember important information, making it easier for you to use it and allowing you to access your account.

This cookie policy allows you to learn more about the origin and use of navigational information collected and processed during your visit to the MYPETSTORIES platform and your options regarding the setting of these cookies.

Technical and operational cookies

When you log on to the MYPETSTORIES platform, technical and operational cookies only may be deposited. It is not possible to set them as their deletion could alter your experience on the platform.

In fact, they are essential to navigation on the platform and their deletion may lead to navigation difficulties on the MYPETSTORIES platform or even the impossibility of accessing said platform.

They also guarantee the security of the MYPETSTORIES platform.

You can set your browser not to receive cookies or to alert you when you receive a cookie. Simply click on the "Help" section of your browser to learn how to change your cookie preferences. If you disable all cookies, you may not be able to access all the features of a website.

Some newer browsers have a "Do Not Track" option that sends a notification to the websites you visit indicating that you do not want your activity to be tracked. At this time, Krealinks does not know about this type of notification because there is not yet a uniform technology standard. We continue to review new technologies and may adopt a standard when one is available.

If our online services include videos, we may target and identify any videos you watch. You authorize us to track your viewing activities through third-party online services or social networks for up to two years, or as long as permitted by applicable law, or until you withdraw your consent.
